## ORDER FOR PARENTAGE TESTING

On April 18, 2008, the Court rendered an order naming the Texas Department of Family and Protective Services (the "Department") as temporary sole managing conservator of 437 children removed from the YFZ Ranch, Eldorado, Schleicher County, Texas (the "Ranch"). The Court finds that an unknown number of males of reproductive age reside, or have resided, at the Ranch during the probable time of conception of one or more of the children the subject of this suit. The Court further finds that an unknown number of females of child bearing age reside, or have resided at the Ranch and could be the mother of one or more of the children the subject of this suit. It is necessary for the Court to determine the biological parentage of each child the subject of this suit. The Court finds that the taking of blood, body fluid or tissue samples for scientifically accepted parentage testing and examination by experts is required in the above numbered and entitled cause pursuant to Texas Family Code Chapter 160. The Court further finds that it is necessary to obtain such samples from all males and females who have been alleged as a parent or assert they are a parent of any child the subject of this suit, and all of the children the subject of this suit for genetic testing to determine the parentage of each subject child.

The Court ORDERS all males who have been alleged as a parent or assert they are a parent of any child the subject of this suit to bring a photo identification (e.g. a drivers license) and report to:

at **10:00 o'clock a.m. on April 22, 2008** to provide samples of blood, body fluid or tissue as required for parentage testing. The males subject to this order include, but are not limited to, those identified on Schedule "A" attached to this Order and incorporated herein for all purposes as if set forth verbatim in the body of this order.

The Court ORDERS all females who have been alleged as a parent or assert they are a parent of any child the subject of this suit, with exception of those presently residing in housing under the supervision of the Department, to bring a photo identification (e.g. a drivers license) and report to:

**Eldorado, Texas 76936**

at **10:00 o'clock am. on April 22, 2008** to provide samples of blood, body fluid or tissue as required for parentage testing. The females subject to this order under this paragraph include, but are not limited to, those identified on Schedule "B" attached to this Order and incorporated herein for all purposes as if set forth verbatim in the body of this order.

The Court ORDERS all females who have been alleged as a parent or assert they are a parent of any child the subject of this suit, and who are presently residing in housing under the supervision of the Department to provide samples of blood, body fluid or tissue as required for parentage testing and to provide a photo identification (e.g. a drivers license) at the time the samples are collected to the agents of the expert appointed by the Court herein to conduct the genetic tests at the following location:

San Angelo, Texas 76903

at 10:00 o'clock a.m. on April 21, 2008. The females subject to this order under this paragraph include, but are not limited to, those identified on Schedule "C" attached to this Order and incorporated herein for all purposes as if set forth verbatim in the body of this order.

The Court ORDERS the Department to make the children the subject of this suit available for the collection of the required samples and to provide such information as is known to the Department concerning the identity and biological relationships of each subject child to the agents of the expert appointed by the Court herein to conduct the genetic tests at the time such samples are collected at the following locations:

San Angelo Coliseum  
503 East 43<sup>rd</sup> Street  
San Angelo, Texas 76903

at 8:00 o'clock am. on April 21, 2008.

AND

Cal Farley's Boys Ranch  
Post Office Box 1  
Boys Town, Texas 79010

at 10:00 o'clock am. on April 25, 2008.

The Court further orders that if the collection of the required samples is not concluded in one day, the Department will make the children available for the collection of the required samples on subsequent days, beginning at 8:00 a.m. The children the subject of this suit include, but are not limited to those children identified on Schedule "D" attached to this Order and incorporated herein for all purposes as if set forth verbatim in the body of this order.

The Court APPOINTS LABORATORY CORPORATION OF AMERICA, INC., by its agents, as the expert to perform parentage testing and ORDERS said expert to identify the aforementioned persons and to obtain a sample of blood, body fluids or tissue from each sufficient for parentage testing in accordance with this order. Said expert shall conduct such testing as is necessary to ascertain the possibility of paternity of one or more of the males subject to this order and to exclude at least 99% of the male population from the possibility of being the father of one or more of the subject child(ren). Said expert shall conduct such testing as is necessary to ascertain the possibility of maternity of one or more of the females subject to this order and to exclude at least 99% of the female population from the possibility of being the mother of one or more of the subject child(ren). To facilitate the testing, said expert is authorized to obtain information concerning biological relatives from each person from whom samples are collected. The Court ORDERS the aforementioned persons to report and provide an additional sample of blood, body fluid or tissue if the expert deems additional samples necessary.

Upon completion of the parentage tests, LABORATORY CORPORATION OF AMERICA, INC. shall promptly report the results of the tests, and its findings, conclusions, and opinions identifying the biological parents of the child(ren) to this Court and mail a copy to the Office of the Attorney General, for distribution of additional copies to each party, or their attorney of record. The costs and expenses of the testing, including the costs of any report, depositions or trial appearance by said expert shall be advanced by the Office of the Attorney General. Such costs and expenses shall be taxed as costs in this proceeding, and adjudged as appropriate on final hearing.

If any party is incarcerated in a criminal correction facility at the time he or she is to provide samples of blood, body fluid or tissue as required for parentage testing, the Court ORDERS that samples to be taken from the incarcerated party by the court-appointed expert shall be obtained in the correction facility. The Court further ORDERS that the correction agency shall allow access to the inmate by the court appointed expert.

**NOTICE**

**The Court notifies all parties that refusal to submit to testing as ordered above may result in the adjudication by the Court of parentage contrary to the position of an individual whose parentage is being determined, and/or a finding of contempt, pursuant to the Texas Family Code §160.622.**
